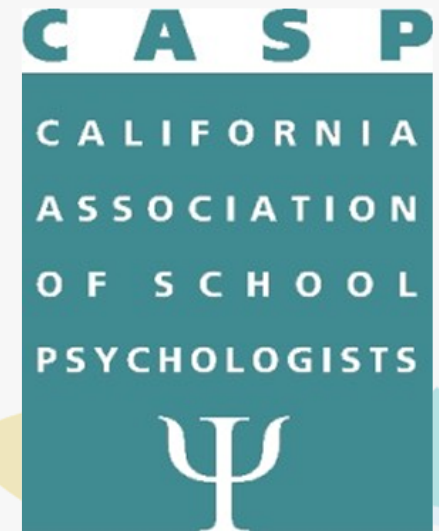

# How does it work?

1. Register for the BOOST Conference  
[www.boostconference.org](http://www.boostconference.org)
2. Indicate in your registration account that you are interested in acquiring and paying for CEUs.
  - *No additional fee will be added to your online account, this is only to determine your interest.*
3. Review the workshop offerings.
  - Workshops that qualify for CEUs will have this symbol:

# On-site at the conference...

1. Upon arrival to the conference and before you attend any CEU approved workshop(s), go to the on-site registration booth in **PSCC Lobby** to turn in your check and pick up your evaluation sheet(s). Add your name and email to the CEU check-in sheet.
  - There is a total flat fee of \$30 per person for one or more qualifying workshops. Please make checks payable to: **California Association of School Psychologists**

# During your CEU workshop...

1. Sign-in & out of the workshop on the CASP sign-in sheet provided by the workshop room host.
2. Fill out the CASP Evaluation sheet you picked up at the on-site registration booth. Return this to the workshop room host prior to leaving your workshop.

# Payment and Processing

- CASP charges \$30 total, per person.
- BOOST participants must pay for this additional fee apart from their conference registration.
- The participant is responsible for turning in a check to BOOST in the amount of \$30.
- **The check must be made payable to CASP (not to BOOST.)**
  - **Payment must be received on-site BEFORE you attend the workshop and pick up your evaluation sheet(s).**
  - **No refunds will be issued if participant does not attend the workshop(s).**



# Paperwork and Processing

- BOOST will send all required information (i.e. your payment, sign-in sheet, and evaluation) to CASP within 30 days after the conference.
- CASP will process the paperwork and payment within two to four weeks of receipt.
- CASP will follow up with each participant with the appropriate documentation that CEUs have been completed and processed.
